

Proposal for a Council Directive amending for the fifth time Directive 74/651/EEC on the tax reliefs to be allowed on the importation of goods in small consignments of a non-commercial character within the Community

THE COUNCIL OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Economic Community, and in particular Article 99 thereof,

Having regard to the proposal from the Commission,

Having regard to the opinion of the European Parliament,

Having regard to the opinion of the Economic and Social Committee,

Whereas Article 1 (4), of Council Directive 74/651/EEC (⁽¹⁾), as last amended by Directive 85/349/EEC (⁽²⁾), provides that every two years, and for the first time on 31 October 1987 at the latest, the Council, acting in accordance with the procedures laid down by the Treaty in the matter, is to adjust the amounts of the reliefs referred to in paragraphs 2 and 2a of that Article in order to maintain real value;

Whereas, according to the survey conducted by the Commission, the weighted average increase in the price

index for the Member States is 6,8 % for the period 1 October 1985 to 30 September 1987;

Whereas the resulting amounts should be rounded off,

HAS ADOPTED THIS DIRECTIVE:

Article 1

Article 1 of Directive 74/651/EEC is hereby amended as follows:

- (a) in paragraph 2 (d), '100 ECU' is replaced by '110 ECU';
- (b) in paragraph 2a, '77 ECU' is replaced by '85 ECU'.

Article 2

1. Member States shall bring into force the measures necessary to comply with this Directive no later than 1 November 1987.
2. Member States shall inform the Commission of the provisions which they adopt to implement this Directive.

Article 3

This Directive is addressed to the Member States.
