on the application of the OECD Understanding on export credits for

EXPLANATORY MEMORANDUM

1. At its meeting of 28 April 1981 the Council decided to conclude on behalf of the Community the OECD Understanding on export credits for ships as it resulted from the negotiations held under the auspices of the OECD and completed on 18 March 1981. At the same meeting the Council also adopted measures relating to application of the Understanding by the Community.
2. The decision of 28 April applied until 31 July; on 20 July a decision was taken extending it until 31 January 1982.
3. The OECD Understanding on export credits for ships is an instrument of international discipline in the field of export credits. It is in the Community's interest that it should continue to be applied after 31 January 1982, but, as in the past, it is desirable that the extension should be for a limited period only.
4. The Commission therefore invites the Council to adopt the draft decision submitted herewith, extending the application of the Understanding until 31 July 1982.

PROPOSAL FOR A

COUNCIL DECISION

THE COUNCIL OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Economic
Community, and in particular Article 113 thereof,

Having regard to the proposal from the Commission,

Whereas the Council Decision of 28 April 1981 on the application of the OECD Understanding on export credits for ships ceases to be applicable on 31 January 1982;

Whereas, in the interests of the Community and in order to strengthen the principle of international cooperation, it is necessary further to extend the period of application by the Community of this instrument of international discipline,

HAS ADOPTED THIS DECISION :

Article 1

The period of validity of the Decision of 28 April 1981 on the application of the OECD Understanding on export credits for ships is hereby extended until 31 July 1982.

Article 2

This Decision is addressed to the Member States.
