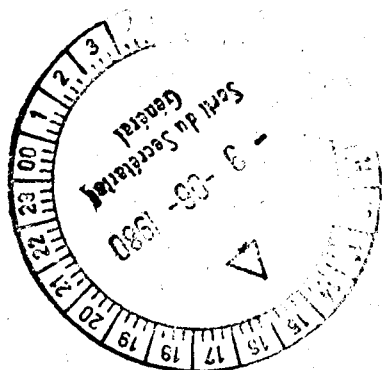

REQUEST FOR THE AUTHORIZATION OF SEVERAL PROVISIONAL TWELFTHS FOR THE EUROPEAN PARLIAMENT

(SECTION I OF THE GENERAL BUDGET OF THE EUROPEAN COMMUNITIES)

COM(80) 320 Final

Subject: Request for the authorization of several provisional twelfths for the European Parliament (Section I of the General Budget of the European Communities)

The headings in question are as follows:

Chapter 10: Members of the Institution

Two twelfths (total appropriations for payments)
(2 874 750 EUA)

Chapter 13: Expenditure relating to missions and duty travel

Two twelfths (total appropriations for payments)
(583 300 EUA)

Chapter 21: Rental of buildings and incidental expenditure

One twelfth (total appropriations for commitments)
(1 006 600 EUA)

Three twelfths (total appropriations for payments)
(3 020 000 EUA)

These additional twelfths are required:

- (a) in order to reimburse Members of the European Parliament for travel and subsistence expenses (Chapter 10);
- (b) in order to enable the Institution to operate at its three places of work (Chapter 13);
- (c) in order to meet certain contractual commitments in this area (Chapter 21).
