Alteration of the proposal for a Council Regulation extending for the years
1972, 1973 and 1974, certain time limits for granting aid from the Guidance
Section of the EAGGF

(Presented by the Commission to the Council
pursuant to the second paragraph of
Article 149 of the EEC Treaty)

EXPLANATORY MEMORANDUM

1. By letter of 20 September 1973, the Commission sent to the Council a proposal for a Regulation extending for the years 1972, 1973 and 1974 certain time limits for granting aid from the Guidance Section of the EAGGF (R 2246/73 (AGRI 641)(FIN 566)).
2. At its November session, the Parliament adopted a resolution giving its Opinion on that proposal. It asked that decisions on applications for aid submitted for the year 1973 be taken not later than 30 June 1974.
3. The Commission, which consider that it would be desirable to reduce considerably the delays in taking such decisions, proposes to take the necessary measures, particularly as regards staff requirements, to enable decisions to be taken as soon as possible, i.e. by 31 July 1974. It is therefore amending its proposal, as permitted under the second paragraph of Article 149 of the Treaty.

1. The fourth recital is amended to read as follows:

"Whereas Article 2 of Regulation (EEC) No 2140/72 provides that the
period for the submission of applications for aid for the year 1973
be extended to 30 June 1973; whereas, in view of the measures to be
taken by the Commission, it will be possible to reduce the period
required for the examination of the applications, which began on
1 November 1973, to eight months; whereas the period within which
the Commission must decide on the merits of the applications should
therefore be extended;"

2. In Article 1, the date "31 October 1974" is replaced by the date
"31 July 1974".
