af 29. september 1970

om indgåelse af en aftale med Israel i henhold til artikel XXVIII, stk. 4, i GATT

(70/450/EØF)

RÅDET FOR DE EUROPÆISKE
FÆLLESSKABER HAR –

under henvisning til traktaten om oprettelse af Det europæiske økonomiske Fællesskab, særlig artikel 113,

under henvisning til beretning fra Kommissionen, og

ud fra følgende betragtning:

Israels regering har i henhold til bestemmelserne i artikel XXVIII, stk. 4, i Den almindelige Overenskomst om Told og Udenrigshandel udtrykt ønske om at trække indrømmelser, der er givet Det europæiske økonomiske Fællesskab tilbage. Der er ført forhandlinger om kompensation for denne tilbagetrækning; de indrømmelser, Israel har tilbudt som kompensation for de tilbagetrukne indrømmelser, er tilfredsstillende –

VEDTAGET FØLGENDE AFGØRELSE:

Artikel 1

På Det europæiske økonomiske Fællesskabs vegne indgås den med Israel i henhold til artikel XXVIII, stk. 4, i Den almindelige Overenskomst om Told og Udenrigshandel forhandlede aftale, hvis ordlyd er vedtaget som bilag til denne afgørelse.

Artikel 2

Indgåelsen af denne aftale meddeles de kontraherende parter i Den almindelige Overenskomst om Told og Udenrigshandel.
